INFORMATION, RULES & REGULATIONS

1. The event is a motor treasure hunt organised by **Institut Bank-Bank Malaysia** to be held from **Saturday, April 14, 2007 till Sunday, April 15, 2007**. The route for the Hunt is expected to be from Kuala Lumpur to Melaka.
2. Participating vehicles shall be motorised and travel on 4 wheels (excluding lorries and buses) having road tax and insurance valid as at the day of the Hunt.
3. Each team shall consist of a driver and navigator, with an option of no more than 2 additional passengers. The Driver and Navigator in each team must possess driving licences valid as at the days of the Hunt.
4. All team members must sign the Declaration & Indemnity Form on the reverse side of the Official Entry Form and submit it together with payment to

5. Entry fee per participant is RM200.00. The entry fee entitles participants to take part in the Hunt, meals, one night stay at Mahkota Hotel, Melaka and a seat at the Dinner-cum-Prize Presentation ceremony to be after the Hunt.

Payment of entry fee can be made via cash, cheque or credit card.
Cash - will only be accepted over the counter at IBBM's office
Cheque - to be attached and sent together with the official entry form
Credit card - entries will only accepted upon successful debit of fees
6. Briefing for the Hunt will be held on Thursday, April 5, 2007 commencing from 6.00 pm and ending at 8.00 pm at IBBM's premises, Wisma IBI, No. 5, Jalan Semantan, Damansara Heights, 50490 Kuala Lumpur, unless otherwise notified. At least 1 member from each team must attend and he/she/they shall be responsible for disseminating all information provided at the Briefing to other members of the team.
7. Changes to entries after submission must be made by the Briefing date and are subject to acceptance by the Organising Committee, otherwise teams will be deemed to comprise members stated in the Entry Form as at Briefing date.
8. Cancellation in writing must be received by the Institute by March 23, 2007, failing which no refund will be made for the fees paid.
9. All treasures and other materials submitted in the Hunt shall belong to the Organiser who shall be entitled to use the same as it deems fit and no team or member thereof shall have any claim thereto.
10. The team that scores the highest number of points in the Hunt less penalty points incurred will be declared the winner and all subsequent positions will be determined on the same basis. Tie-breakers in the event of a tie shall be as announced to the participants at the Briefing.
11. Car stickers as may be provided by the Organiser are to be placed on all participating vehicles for the duration of the Hunt.
12. The Organiser reserves the right without assigning any reason for the same to:-
 - (a) abandon, cancel or postpone the Event as deemed necessary;
 - (b) reject any Entry whether before or after the acceptance thereof;
 - (c) bar or exclude any one or more members from any team;
 - (d) disqualify and/or impose penalty points on any team found to have been guilty of :-
 - (i) the breach of these Rules and Regulations or road traffic rules,
 - (ii) collaboration or cheating in any manner,
 - (iii) providing a false Declaration, and
 - (iv) failing to complete the Hunt within stipulated time.
13. These Rules and Regulations may be added to or amended at the discretion of the Organiser. These Rules, all additions and amendments thereto, and instructions and rules given by the Organiser, the Clerk-of-the-Course and Marshals at Briefing and during the Hunt, the interpretation thereof and the decision of the Organiser in all matters concerning the Event shall be final and binding on all participants.
